Payment Schedule for Summer for Customers	
15-Oct	A non-refundable deposit payment of \$500 is due October 15th along with the signed agreement. Balance is payable in two installments.
1-Dec	Second payment due December 1st is equal to half total summer cost less initial credit of \$500
1-Mar	Remaining balance is due March 1st.
<b><i>Three Belles Marina will not hold slips after December 1st without a signed contract received by our office. Late payments or checks returned for insufficient funds will be subject to an additional fee or finance charge. No refunds will be made after April 1st.</i></b>	

*By signing this agreement I acknowledge that I have received, read and agree to all the terms and conditions outlined in the "General Marina Rules & Terms of Agreement". I understand that there are no refunds under this agreement after April 1st. I also understand that I must have a valid credit card on file with Three Belles Marina at all times or no service can be provided or work performed. Payment in full is due before the vessel will be released or upon invoicing. I agree to pay all service charges and collection fees on unpaid invoices should collection become necessary. I further authorize the use of my credit card to fully pay any balance outstanding for more than 7 days. Verbal authorizations will not be accepted and this agreement is not complete until this section is signed and returned to Three Belles Marina.*
