Payment Schedule for Winter Storage Customers	
1.)	Deposit of \$500 (boats up to 25ft), \$750 (boats 26 to 31ft) or \$1,000 (boats longer than 32ft) is due with signed agreement and before the boat is hauled or scheduled to be hauled.
2.)	Balance due upon completion of the haul.
3.)	Additional winterization, repair or spring commissioning services may be billed separately.
Late payments or checks returned for insufficient funds will be subject to an additional fee or finance charge.	

By signing this agreement I acknowledge that I have received, read and agree to all the terms and conditions outlined in the "General Marina Rules & Terms of Agreement". I understand that there are no refunds under this agreement. I also understand that I must have a valid credit card on file with Three Belles Marina at all times or no service can be provided or work performed. Payment in full is due before the vessel will be released or upon invoicing. I agree to pay all service charges and collection fees on unpaid invoices should collection become necessary. I further authorize the use of my credit card to fully pay any balance outstanding for more than 7 days. Verbal authorizations will not be accepted and this agreement is not complete until this section is signed and returned to Three Belles Marina.

Note: Summer season runs from April 15th to October 15th and winter storage is from October 15th to April 15th. Boats not launched during their scheduled launch week or by the 1st week of June will be charged each week at the inactive storage rate.
